## GreenWizard Inc. Privacy Statement

Amended July 1 2011

This Privacy Policy explains how GreenWizard gathers, uses and discloses information about its visitors ("you"), and with regards to, your use of the GreenWizard service.

GreenWizard, Inc. ("GreenWizard," "we" or "us") respects the privacy of the visitors to its website, the home page of which is located at <http://www.GreenWizard.com> (the "Site"). This Privacy Policy is intended to inform you of our policies and practices regarding the gathering, use and disclosure of Personal Information you submit through our Site. This Policy is hereby incorporated in our Terms of Use and by registering for our services you accept the terms of this Privacy Policy. Personal information ("Personal Information") is information about you that is personally identifiable to you, like your name, address, or personal phone number, as well as other non-public information that is associated with the foregoing.

### Consent

By using the Site, you signify you understand we have a Privacy Policy and you expressly consent to the processing of your Personal Information according to this Privacy Policy. Your Personal Information may be processed by GreenWizard in the country where it was collected as well as other countries (including the United States) where laws regarding processing of Personal Information may be less stringent than the laws in your country.

### Your Information

The GreenWizard services ("Services") are password-protected. To use the Services, you must sign up and provide us with contact information. If you are a registered user, we track your first name, last name, User ID, password, address, phone number, email address and relevant associated company information. We may, in the future, include other requests for information from you to help us to improve the services offered through our GreenWizard Site. We reserve the right to add pertinent information to our tracking capabilities.

### Automatically Gathered Information

GreenWizard may collect browser type and browser software version to tailor the presentation of the Site and the services to your platform and to maintain a record of your activity on the Site. As an automatic process, we may record a log IP addresses that access the Site. We may also collect IP information.

We can and will use IP addresses to identify a User when, in our sole discretion, we determine that it is necessary to enforce compliance with our Terms of Use or to protect our Service, Site, and/or registered users.

### Cookies

Cookies are tiny data files that are stored by your browser on your computer hard drive. We use cookies, to track user trends and patterns and to otherwise improve the overall user experience on the Site. You always have the option of disabling cookies via your browser preferences. If you disable cookies on your browser, please note that some parts of our Site may not function exactly the same (e.g. as effectively or as quickly).

### How We Use/Disclose Information

We use information for GreenWizard's own internal purposes including contacting you via email to inform you about updates to our services and providing you with information about your use of the Site, as well as to support the features and functions of the application.. While we may need to share your Personal Information for purposes of supporting your use of the Site, we will not rent or sell your Personal Information to third parties without your consent. We may provide you with updates, announcements, newsletters, business contacts, etc. via email or through the application. You may opt out of receiving email information at any time.

We may share your Personal Information in the following circumstances:

- If you have directed us to do so
- If we are transmitting messages on your behalf to customers or other third parties specified by you or we have engaged to facilitate the Service and/or
- If we are required by law or in response to a court order

GreenWizard cooperates with law enforcement inquiries, as well as other third parties to enforce laws, such as: intellectual property rights, fraud, theft, harassment and other rights. We can (and you authorize us to) disclose any information about you if we believe in good faith that such disclosure is necessary (a) to comply with relevant laws or to respond to subpoenas or warrants served on us; (b) to protect or defend the rights or property of GreenWizard or third parties; or (c) to assist in an investigation.

Although we presently are singularly owned and operated, we may in the future have subsidiaries, joint ventures, or other companies under a common control (collectively, "Affiliates"). We may share some or all of your Personal Information with these Affiliates, in which case we will require our Affiliates to honor this Privacy Policy. If our company or our assets related to the Site are acquired by another company, that company will possess the Personal Information collected by us and it will assume the rights and obligations regarding your Personal Information as described in this Privacy Policy.

On a regular basis, we may opt to disclose usage information in aggregate form to third parties, including manufacturers, for a number of business purposes, including marketing and market research.

We do not intentionally gather Personal Information about visitors who are under the age of 16.

In the course of using the Services as a subscriber, you may provide other information, such as messages, contacts, uploaded documents, and submittals, to us ("Customer Data").
